SARS Cov-2 were first reported by the officials in Wuhan city, China in December 2019. Some of the earliest known cases had a link to a wholesale food market in Wuhan. Many of the initial patients were either stall owners, market employees or regular visitors to this market. Environment samples taken from this market in December 2019 tested positive for SARS Cov-2, further suggesting that the market in Wuhan city was the source of this outbreak or played a role in the initial amplification of the outbreak. The genetic sequence of SARS Cov-2 shared publicity on 11 to 12 January 2020. The full genetic sequence of the virus from the early human cases from China and all over the world show that SARS Cov-2 has an ecological origin in bat population and all available evidence todate suggest that the virus has a natural origin and is not a manipulated or constructed virus. Another Coronavirus, SARS Cov-1 that caused severe acute respiratory syndrome (SARS) outbreak in 2003 was also closely related to the other Corona viruses isolated from bates [3]. Again, the scientists analyzed the genetic template for the spike protein armatures on the outside of the virus that uses to grab and penetrate the outer walls of human cells. They focused more specially on two important features of the spike protein, the receptor binding domain (RBD), and cleavage site, that allows the virus to crack open and enter host cells. They found that the RBD portion of the SARS Cov-2 spike protein had evolved (via mutation) to effectively target a molecular feature on the outside of the human cell called angiotensin converting enzyme 2 (ACE2), involved in regulating blood pressure. The researchers considered this finding to be the result of natural selection and not as the product of genetic engineering. Another finding was that the backbone of SARS Cov-2 differs substantially from those of already known corona virus and mostly resembles the related virus found in bats. This is again an additional support to rule outthe laboratory manipulation theory of SARS Cov-2 [4]. In spite of these facts, that too supported by many research centers of different countries, unfavorable views of China is increasing day by day. According to a 14 country pew research center survey, highest level of unfavorable opinion of China could be seen in Australia, the united kingdom, Germany, the Netherland, Sweden, the United states, South Korea, Spain and Canada. Majorities say China has handled Covid-19 outbreak poorly. The Americans think that their govt, should hold China responsible for the role it played in the outbreak of the Coronavirus

Now, what is the solution? A 3rd world war? If, that's the only solution, it will be at the cost of another few hundreds of thousands of lives to be followed by the aftermaths of the fallout radiations of the nuclear arsenals if used. The author's sincerest dream, never expected to be in reality at this point of time is the reunion of the groups separated and reformation of a single world body represented by one member from each country. Every piece of land should be the property of the single Govt.; no need of fighting for grabbing it. A common army pool should be there just to see only the law and order situations.
