Abstract

This study investigates the enhancement of parental engagement in government schools within the Solukhumbu district. The research aims to assess current levels of parental participation, identify key barriers, and propose effective strategies for improvement. Employing a qualitative research methodology, data were gathered through semistructured interviews with twenty purposively selected head teachers from secondary schools. The analysis of the data yielded several critical findings. Geographical distance emerged as a significant obstacle to parental engagement, indicating a pressing need for virtual meetings and decentralized interactions to improve accessibility. Additionally, while parental involvement is robust within School Management Committees (SMCs), it tends to decline at the secondary education level. This trend underscores the necessity for tailored engagement strategies that cater specifically to the needs of older students and promote transparent communication between schools and parents. Furthermore, addressing barriers such as low parental literacy through targeted educational programs and enhancing communication channels is essential for fostering active parental engagement. The insights derived from this study provide valuable guidance for improving educational outcomes and nurturing a supportive learning environment in the government schools of Solukhumbu district.

Introduction

Parental involvement in education is widely recognized as a critical factor in improving educational outcomes and overall school effectiveness (Hill & Tyson, 2009). In Nepal, despite efforts to promote parental participation in government schools, challenges persist that hinder effective collaboration between schools and parents (Ministry of Education, Science, and Technology (MoEST, 2020). This lack of involvement has been linked to various factors, including socioeconomic disparities, cultural beliefs, and institutional barriers. Recent studies underscore the importance

of fostering meaningful partnerships between schools and families to enhance student academic achievement and socio-emotional development (Pokhrel, 2020). However, existing literature indicates a gap in understanding effective strategies tailored to the Nepalese context that can bridge the communication and engagement gap between schools and parents (Beutel et al., 2018).

Furthermore, global trends highlight innovative approaches such as community engagement programs and digital platforms that have successfully increased parental involvement in education (UNESCO, 2021). These strategies

emphasize the importance of inclusive policies and culturally responsive practices that empower parents from diverse backgrounds to actively participate in their children's education (World Bank, 2024). In light of these insights, there is a pressing need for empirical research focused on identifying culturally appropriate and effective strategies for enhancing parental participation in government schools in Nepal. By addressing these gaps, this study aims to contribute valuable insights that can inform policy and practice to foster collaborative partnerships between schools and parents, ultimately improving educational outcomes for students across Nepal. Recent studies highlight that parental involvement positively influences student achievement, motivation, and behavior (Desforges & Abouchaar, 2003; Fan & Chen, 2001). However, in Nepal, factors such as socio-economic disparities, cultural beliefs, and geographical remoteness often hinder effective parental engagement (Khanal, 2015). For instance, parents from marginalized communities may face barriers such as illiteracy and lack of awareness regarding their roles in supporting their children's education (Oranga, et al., 2022).

Moreover, the structure and functioning of government schools in Nepal present specific challenges to fostering parental participation. Research indicates that school infrastructure deficiencies. inadequate teacher-parent communication, and limited opportunities for parental involvement in decision-making processes contribute to low levels of engagement (Maharjan, 2016). These factors underscore the need for targeted strategies that not only recognize cultural and socioeconomic diversity but also empower parents to actively participate in their children's education within the framework of government schools. Internationally, successful initiatives to enhance parental participation have emphasized the importance of collaborative partnerships between schools, communities, and families (Henderson & Mapp, 2002; Patrikakou & Weissberg 2007). In Nepal, pilot programs and localized efforts have shown promising results by fostering mutual trust, providing parental education workshops, and integrating culturally relevant practices into

school activities (Maharjan, 2016). However, these initiatives are often fragmented and lack systematic implementation across government schools nationwide.

Given the complexity of factors influencing parental participation in Nepalese government schools, further empirical research is needed to develop evidence-based strategies that address contextual challenges while leveraging local strengths. By bridging the gap between research and practice, this study aims to contribute to the development of sustainable interventions that enhance parental involvement and ultimately improve educational outcomes for all students in Nepal.

Despite the recognized importance of parental involvement in enhancing educational outcomes and overall school effectiveness, government schools in Nepal, particularly in the Solukhumbu district, continue to experience low levels of parental participation. This persistent issue is compounded by various factors, including socioeconomic disparities, cultural beliefs, and institutional barriers, which hinder effective collaboration between schools and parents. Furthermore, the existing strategies for promoting parental engagement are often fragmented and lack systematic implementation, resulting in suboptimal outcomes. There is a critical need for empirical research to identify the current levels of parental participation and develop culturally appropriate and effective strategies that can be implemented across government schools in the Solukhumbu district. This plan acknowledges barriers faced by parents, such as illiteracy and socio-economic constraints, proposing targeted interventions to address these challenges (MoEST, 2020).

Local initiatives in Nepal have demonstrated promising results. For instance, pilot programs that integrate traditional cultural practices into school activities have successfully engaged parents from marginalized communities. These programs emphasize the importance of culturally relevant approaches in fostering parental participation (Henderson & Mapp, 2002). However, there is a concerning decline in parental attendance at the secondary level, despite high consent rates for activities such as midday meals in primary grades. This decline suggests that parental priorities shift as children advance through their schooling. Schools can address this disparity by tailoring meaningful engagement opportunities specifically designed for older students and maintaining transparent communication channels with parents to keep them informed and involved.

Disparities Between School Types

Private institutions often exhibit higher engagement rates, suggesting that public schools could benefit from adopting successful practices from their private counterparts.
